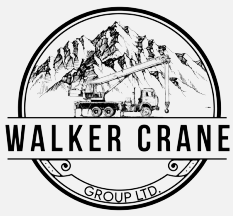

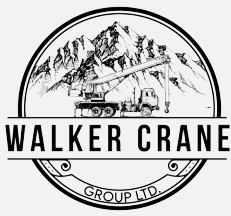

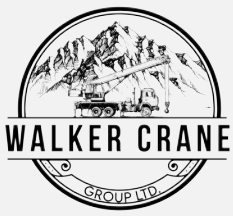

Statement of Student Rights
